Sheriff's Office

- There were 415 traffic stops in April with 16 citations, as the deputies are focusing on educating the public.
- On May 11 at the Silverland Parking Lot, a child safety seat check will be held.
- From May 13-31 Joining Forces will have a "Click it or Ticket" campaign, which is grant funded.

• Speed bumps are coming back to Virginia City streets soon.

Fire District

- There will be a Living with Fire presentation from 9 to 11 a.m. at Station 72 in the Virginia City Highlands.
- The district has added one inspector, and one plans examiner.

Operations and Projects

• The Lockwood Senior Center went out to bid, which will be presented on July 2.

Planning Department

- Storey County received a \$36,500 grant from the Carson Water Subconservancy District for drainage improvements to Six Mile Canyon Road including new culverts.
- CWSD received notice they are being funded for the Mark Twain Area Master Plan.
- CWSD also has a list of projects to submit to the Federal Emergency Management Agency for a Gold Hill, Divide, and Silver City drainage plan.

Planning Manager Kathy Canfield read the title for the public hearing. She said this is the 2nd reading to change the minimum dwelling size. No comments were made to the department.

• For National Public Service Recognition Week, Austin Osborne thanked and praised all county departments, noting their vast responsibilities and how important they are to the residents.

Clerk-Treasurer

- The sign ordinance was not in the current packet, but previous clerks did have it in the packet. The Office is still working on getting that online, and will link to the ordinance on the website.
- Early Voting starts on Saturday, May 24, The Office is busy preparing for the election.
- A mock election of the new Voter Registration & Election Management System (VREMS) was done with the Secretary of State's Office and highlighted some functions that still need to be updated.
- The delinquent property tax list will be in the newspaper paper this week. There has been a 6 percent reduction in delinquencies from the previous fiscal year.

BOARD COMMENT (No Action - No Public Comment):

- Commissioner Carmona said Virginia Highlands resident and former VCH road manager Bob Moore has passed away.
- 11. DISCUSSION ONLY: Storey County FY25 Tentative to Final budget update.

Comptroller Jennifer McCain said this is just a discussion item, and went over the changes from the tentative budget approved in April to the final budget to be approved at the next meeting. She also discussed various special funds. The budget can be found on Page 72 of the Board of Commissioners packet under agendas on the Storey County website.

Ms. McCain said that the differences between the tentative and the final budgets include a 3 percent increase in revenues and a reduction in expenses of 4 percent and an increase in transfers out of 49 percent. The new ending fund balance is at about \$9.5 million, or a reduction of about 36 percent. The reduction in expenses is mainly due to the lower-than-expected insurance increase from 15 percent to 10 percent. She said the increase in transfers out was used for the Capital Improvement Program projects in the Capital and Roads funds as well as smaller changes in the county's other funds.

In response to a question by Commissioner Mitchell, Ms. McCain said she was comfortable with the amount of expected personal property tax revenue.

12. DISCUSSION/FOR POSSIBLE ACTION: Approval of modification and extension of 2023-2024 Collective Bargaining Agreement between Storey County (Employer) and the Storey County Sheriff's Office Employees' Association/Nevada Association of Police and Sheriff's Officers (NAPSO).

County Manager Osborne asked to continue this item.

Motion: I, Commissioner Mitchell, move to continue Item #12, which is about the collective bargaining agreement between Storey County and the Storey County Sheriff's Office Employees Association to our next regularly scheduled commission meeting on May 21 here at the courthouse and on Zoom. **Seconded by:** Lance Gilman. **Vote:** Motion passed unanimously.

13. DISCUSSION/FOR POSSIBLE ACTION: Consideration and Possible Approval of Grant of Easement File No. 2024-017 to NV Energy for communication and gas facilities within a portion of the Waltham Way Right-of-Way and Alexandria Ct. Right-of-Way, McCarran, Storey County, Nevada.

Planning Manager Kathy Canfield said this request from NVEnergy for an easement has been reviewed by Public Works and staff recommended its approval. Findings are on Page 252 of the Board of Commissioners packet located on the Storey County web site under Agendas.

Motion: In accordance with the recommendation by staff, I, Commissioner Mitchell, move to approve a Grant of Easement (2024-017) to NV Energy for utilities within a portion of the Waltham Way Right-of-Way and Alexandria Ct. Right-of-Way, McCarran, Storey County, Nevada. **Seconded by:** Lance Gilman. **Vote:** Motion passed unanimously.

14. DISCUSSION/FOR POSSIBLE ACTION: Consideration and possible approval of Interlocal Agreement Between Storey County and Storey County Fire Protection District for the partial-grant-funded construction of and for the Fire District's purchase of Fire Station 71 located at 145 North C Street (APNs 001.094.03 and 001.094.02), Virginia City, Nevada.

County Manager Austin Osborne said the draft interlocal agreement is for Fire Station 71, which is owned by the county and operated by the Fire District. Lara Mather and Honey Coughlin have secured a federal grant of \$3.7 million for the project, but it has to be a county project, not a Fire District project. Fire Chief Jeremy Loncar wants to expand the station, adding dorms, office space, and additional bays. This interlocal agreement allows the county to work with the Fire District to help manage the project to completion, then the county

would sell the project to the Fire District at cost. Then it would be a Fire District-owned property. There is a similar item in the Fire District section.

16. DISCUSSION ONLY: Report of Public Works Department regarding roads and highways throughout Storey County.

Public Works Director Jason Wierzbicki said there is an accepted bid for Lousetown Road, and work will begin soon, first with flaggers and culvert repair, then it goes to 1 lane only traffic. Work is expected to go to August 9.

He also said the 2024 Road Rehab Project is going to bid. There will be a full chip seal for Wild Horse Canyon Drive, Ireland Drive, London Drive, and a full reconstruction of Summitt Street. The department is also working on the Justice Court parking lot.

Public Comment: None

17. RECESS TO CONVENE AS THE STOREY COUNTY WATER AND SEWER BOARD

18. DISCUSSION ONLY: Storey County Water and Sewer FY25 Tentative to Final budget update.

Comptroller McCain said this regards changes in the Water and Sewer FY25 budget from the tentative to the final budget. Water and Sewer funds are a rocky situation, so we are asking for transfers from the Infrastructure Funds to help these enterprise funds pay the bonds off on upgrades to their systems. Ms. McCain described the amounts in the funds and the amounts needed to be transferred; \$98,568 for Water and \$210,000 for Sewer. The Water and Sewer budgets are on page 268 of the Board of Commissioners packet under agendas on the Storey County website.

20. DISCUSSION/FOR POSSIBLE ACTION: For consideration and possible approval of the First reading for On-Sale/Off-Sale Liquor License. Applicant is Jagmohan Dhillon, Sparks Hotel, LLC DBA Courtyard by Marriott-Reno/Sparks-McCarran located at 505 USA Parkway, McCarran, NV 89437

Deputy Frank Valdez said he did an extensive background check on the applicant, and said that while he had positive references and had been in the hotel business for about 20 years, there were disqualifiers such has had 51 tax liens for substantial amounts, civil judgements, and a foreclosure. When seeking criminal background information, the FBI did not give them any information.

Commissioner Gilman wants to make an exception to the disqualifiers and approve. He said he has known the applicant for many years, and he has struggled at times. Marriott has supported them in this project.

Commissioner Mitchell asked if there were other properties which the owner is involved that are part of chains. Deputy Valdez said the applicant is listed as primary. Mr. Mitchell further asked how the liquor license should be used. Deputy Valdez said it would be off-sale for service in rooms and hospitality.

Sheriff Mike Cullen said this is only the first reading, and further investigation could be done at the second reading, where the applicant could come in and speak.

Public Comment: Gary Schmidt, who has held liquor licenses in the past, said he could not find the item in there. Asked if the report is included in the agenda item? It is on page 269. The item is included, not the report. He wanted things tabbed. Commissioner Gilman said he knew the person and could be a reference or it could be a conflict of interest.

Motion: I, Commissioner Mitchell, move to approve the First Reading On-Sale/Off-Sale Liquor License. Applicant is Jagmohan Dhillon, Sparks Hotel, LLC DBA Courtyard by Marriott-Reno/Sparks-McCarran located at 505 USA Parkway, McCarran, NV 89437. **Seconded by:** Lance Gilman, **Vote:** Motion passed unanimously.

21. RECESS TO CONVENE AS THE STOREY COUNTY FIRE PROTECTION DISTRICT BOARD

22. DISCUSSION ONLY: Storey County Fire District FY25 Tentative to Final budget update.

Comptroller McCain said the changes between the Tentative and Final budgets are a 7 percent increase in revenues and a 6 percent increase in expenses. With added income from investment interest and the SAFER grant; and increase in wages and benefits, the ending fund balance is expected to be \$6,604,000. The Fire Capital Fund also increases due to

investment income. The ending fund balance for this fund is \$337,000. The Grant Fund includes three state grants and five federal grants, bringing the balance to \$1.5 million.

23. DISCUSSION/FOR POSSIBLE ACTION: Consideration and possible approval to proclaim May 2024 as Nevada Wildfire Awareness Month in Storey County.

Fire Chief Jeremy Loncar read the proclamation into the record.

Chief Loncar said this was the oldest ambulance in the fleet and would require considerable maintenance long-term.

Chief Loncar said this interlocal agreement is a necessity as the current property is a county owned facility. To bring it up to the needs the district has, Lara (Mather) has procured a federal grant. The way this agreement is drafted, it would lead to the county funding the construction of this facility, and at the completion of that construction, the fire district would purchase it with money used in this construction. It was a collaborative effort between the county and the fire district.

Grants Manager Sara Sturtz said this engineering report is required by the USDA to obtain the federal grant to complete Phase I of the Fire Station 71 project. Universal Engineering Sciences (UES) would do the required inspection to assess the subsurface and environmental conditions at the proposed site of construction. After work is completed, UES will submit an engineering report to the County, which will be sent to the United States Department of Agriculture for review and approval.

Operations and Projects Manager Mike Northan said the easement will enable NV Energy to provide and install underground electrical utilities for the Lockwood Senior Center project. The Line Extension Agreement (LEA) is provided to show the proposed utilities location.

Energy for utilities associated with the Lockwood Senior Center Project. **Seconded by:** Lance Gilman. **Vote:** Motion passed unanimously.

29. DISCUSSION/FOR POSSIBLE ACTION: To possibly accept a proposal for the design of the Mark Twain Community Center – Phase 1, a metal building for the storage of fire apparatus submitted by Paul Cavin Design in an amount not to exceed \$246,500.00. This proposal includes architectural, structural, mechanical, civil, and electrical design.

Mr. Northan said This is a proposal for design services for a building to store fire apparatus in preparation for a remodel of the existing community center.

Commissioner Mitchell noted the high expense for the cost, and asked if it was the going rate. Mr. Northan said the increase in construction prices has outstripped other sectors. It would be less expensive for a skin-stretch building, but would only work for a short time.

Public Comment: Hugh Gallagher said this is a lot of money for a rebuild. Is there discussion of building something new for Mark Twain residents. This is an old building originally built for the fire department. Commissioner Carmona said the best concept the county has decided on, since we don't have the ability to staff this station, we would build this project. County Manager Osborne said a committee that included the fire chief and senior services director looked at all the options for this project, and what it would look like 10 years out. Senior services liked the existing building. A new building would cost \$5 million to \$7 million.

Mr. Osborne said this parcel was near the jail, and we are looking at the potential purchase of the property, which is encroaching on jail property and could be used to expand the parking lot and provide drainage. The owners were contacted and were interested in selling. The county must appraise the property and Mark Stafford is the next appraiser on the rotation list. After the appraisal we will look at purchasing the property.

32. DISCUSSION/FOR POSSIBLE ACTION: Consideration and possible approval of the draft FY25 Storey County Capital Improvement Plan and to direct county staff to continue working on fiscal years 26-29.

Administrative Officer Honey Coughlin said she and Comptroller McCain have worked to ensure the FY25 projects listed in this CIP match the requested projects in the tentative FY24/25 budget. Upon approval, county staff will begin working on fiscal years 26-29 in the CIP to complete a 5-year Capital Improvement Plan to present for board approval. Many projects have changed and may be completed sooner, and others may be pushed to FY26 or later. She said some projects will begin in one year and will continue into another year. In the future she will note different phases stretching over more than one fiscal year, she will note that.

The proposed Capital Improvement Project Plan is on Page 415 of the Board of Commissioners packet under Agendas on the Storey County web site.

Chapter 17.84 Signs and Billboards

17.84.110. Section M.


Signs associated with the national, state or local election processes shall be consistent with the following:

- 1. Signs, posters and banners shall not be displayed prior to the first day allowed for the filing of candidacies for election.
- 2. Signs, posters and banners may not be placed on private property without the private property owner's permission.
- 3. Unsuccessful primary candidates must remove, or cause to be removed, their signs or posters no later than 30 days after the primary election.
- 4. All signs, posters and banners associated with national, state or local elections shall be removed no later than 30 days after the general election.
- 5. Signs, posters and banners may not be affixed or placed on the public domain. The public domain placement restriction does not apply to signs placed on the county-owned property located as shown in Appendix A. Signs located in these public areas shown in Appendix A shall be permissible up to 32 square feet.
- 6. Sign, posters, and banners shall not exceed 32 square feet. Signs, posters and/or banners may have copy on both sides. Only one side is counted toward the overall allowable sign area.
- 7. The sign owner is responsible for knowing the location of the abutting state and county right-of-way and for complying with state and federal regulations.
- 8. The county is not responsible for state right-of-way non-compliance or penalties imposed against the sign owner for violation of those regulations.
- 9. There is no limit on the number of signs or posters that may be placed on a parcel.
- 10. Lighting installed specifically for signs, posters and banners is not allowed.
- 11. Signs, posters and banners located near property lines and intersecting driveways and public right-of-ways are allowed outside of the vision clearance triangle as demonstrated in section 17.84.080.G. Any sign located within the vision clearance triangle must have a base that is higher than 8 feet above street/grade level or a total height not exceeding 3 feet above street/grade level. In instances where a safety or traffic hazard is identified with regard to these requirements, additional or more restrictive conditions may be imposed. Otherwise, setback requirements apply as follows:
 - a. C, CR, E, and R zones 7 foot clearance setback;
 - b. All other zones 25 foot clearance setback.



Appendix A Locations for signs associated with national, state or local election processes within Countyowned rights of way or property.


The identified locations are approximate only (indicated in yellow or blue on the following maps). Signs associated with the election processes may be located on Storey County public right-of-way/property only in the general locations shown. No signs may be located that impede pedestrian or vehicle visibility and may not be located within a vision clearance triangle. Signs located in these public areas shall be permissible up to 32 square feet regardless of the zoning district. It is the sign owner's responsibility to make sure signs are not on private property without permission from the property owner and not located in any other public right-of-way. Signs must be located a minimum of 100-feet from a polling location.
